MEMBERSHIP CONDUCT REVIEW

At any point during the golf season, if a member does not uphold River Spirit standards, the member may be subject to expulsion from the club. River Spirit will adhere to a strict procedure in such matters. The member in question will first receive an informal verbal warning from management (to be recorded by management). Should the infractions persist, the member will receive a formal written warning from management, and in the event that the member still does not adjust their behavior accordingly, River Spirit will issue a letter terminating their membership. Any member expelled from the club will receive a prorated refund of One Seventh of their dues per month remaining in the golf season April - October. River Spirit conduct review policy is designed to protect the interests of the majority of the membership from the inappropriate actions of a few.
